Statutory Consultation – New Intensive Support Provision (ISP) at Kinross High School

The Learning & Families Committee of Perth and Kinross Council has agreed the requirement for a new ISP to be established at Kinross High School. The Council is now undertaking a statutory consultation on the following proposal:

- To permanently establish a new ISP within the existing site at Kinross High School for pupils with Additional Support Needs with effect from January 2026.
